Information for Getting Out Of Band 6!

The sample answer has a common problem for candidates stuck between band 6 and band 7: the writing contains a mixture of different levels. To use a sports analogy, this is like a tennis player who is learning a new, more advanced tennis shot, and is not ALWAYS successful in making the shot. The tennis player will only achieve success when he or she can make the shot **consistently.** The same idea applies to reaching a higher level in IELTS writing.

LANGUAGE PROBLEMS: The first image below shows the sample answer with some general comments. There are language errors found at band 5 and band 6, but there are also examples of higher level language. I have used different colored highlighting to show this.

The answer also has problems when it comes to Coherence and cohesion. Look again at the first body paragraph. The ideas in this paragraph are not in a logical order, which makes the ideas difficult to follow and will keep the score below band 7.

The following order is more logical and therefore easier to follow:

- 1. Recycling of household waste should begin in the home
- 2. (However,) not everything can be recycled
- 3. (So,) the government should educate people about this
- 4. (Furthermore,) in order to increase recycling, the government should also make separating waste mandatory.

Compare this to the current order:

- 1. Recycling of waste should begin in the home
- 2. The government should make people classify waste
- 3. Not all products can be recycled
- 4. Recycled and non-recycled waste should be classified
- 5. The government should teach people about waste

Who claims this? This is not what the question means – 'being recycled' is not the same as 'able to be recycled.' This sentence just repeats your first sentence.

There is a cohesion and coherence problem in this paragraph: The order of your ideas is not logical and so it is difficult to follow, Look carefully at the order I have suggested below.

This extra sentence does not add to the ideas in this paragraph, and so it seems irrelevant here. It also makes this paragraph much longer than the next body paragraph, and so your essay feels unbalanced. This sentence could be added to the next paragraph, where it fits logically
